### **Meet and Greet**

#### Bring Your Child's School Supplies!

Meet and Greet will be on August 9th, 2017 from 1:00 p.m. to 3:00 p.m. for grades K-5. VPK Meet and Greet will be at 12:00 p.m. This is opportunity for you to meet your child's teacher. You will also be able to gather information about transportation and after-school programs that are available. We encourage you to bring your child's school supplies. Your child's teacher will be there to help place the supplies in the designated area of the classroom. Please label the supplies with your child's name. We are looking forward to seeing all of our Little Dolphins!!

### **Staggered Start for Kindergarteners**

Your child will attend only one day of the first four days of school. Groups of five children per class will be assigned to attend school only one day during August 10nd through 15th. All kindergarten students will attend school on Wednesday, August 16th. The smaller groups will allow the children and teacher to become more familiar with each other, as well as with the classroom routine. We believe the students will benefit from the individualized attention during this critical period.

All kindergarten students will attend their second day of school on Thursday, August 17th and will continue as a whole group from that point.

(We will implement Florida's "Class Size Amendment" for each classroom. As a result, forming classes has been a challenge to meet the state mandated requirements. Please refrain from requesting a change in your child's placement. However, changes in homeroom could occur if enrollment changes in order for us to be in compliance with the state's class size amendment. If any changes should occur, the school will be in contact with you prior to the change).

### **What Bus Does Your Child Ride?**

The Transportation Department will publicly publish school bus routes on Thursday, 27 July 2017 for use by student riders, parents and/or guardians. Transportation will publish routes via School Messenger (email, voice, and text), on line (under Transportation on the district public website), and on HAC (once schools release homeroom assignments). If you have question regarding bus transportation, please call the SJCSD transportation department at 904-547-7810.

#### Transportation Services Waiver

Schools are no longer authorized to issue Bus Passes or instruct bus operators regarding bus ridership or stops. Instead, the Transportation Department is now responsible for issuing provisional Transportation Services Waivers for a specific period of time due to extenuating circumstances. Parents may apply for this waiver via the St. Johns County School District webpage under the "Transportation Department."

Waivers will not be available from individual schools.

You will be receiving a text or email from the St. Johns County School District asking if you would like to "opt-in" to School Messenger. We encourage you to participate in this mode of communication, as it will be one of our main ways to communicate information to you. We often send emails, voice messages, or texts to our families to keep you informed of important dates, events, and other school news. Please clearly print your phone number when completing the Emergency Card so that correct information is in our system. An incorrect number would prevent you from receiving this valuable information.

An email address is available for all staff members. Please remember that all emails and voice messages are subject to public record. Voice messages are now stored electronically. Please refrain from leaving confidential information.



#### eSchoolPlus Home Access Center (HAC) at KES this school vear 2017 - 2018

The St. Johns County School District (SJCSD) offers parents and students a tool to monitor their (child's) academic progress. The Home Access Center (HAC) is a web-based application that is part of the Student Information system, eSchoolPlus. The HAC portal is available to registered parents and/or guardians, and to enrolled students.

The HAC portal provides parents and students with a daily summary page of student information including schedule and attendance, discipline information, class work, test scores, grades and course requests. It also allows students to view their own records in the system to help keep them informed and actively participating in their progress.

"The HAC portal enables parents the ability to receive timely information to support and monitor their children's academic progress. The HAC portal serves as an excellent additional tool to communicate information, but should not be considered the only form of interaction with the school."

Parents who do not have access to a HAC account must first visit their child's school to complete an email verification form and show a positive form of identification. This can be accomplished during our KES Meet and Greet on August 9th from 1:00p.m. - 3:00p.m. Once parents have completed the email verification form at their school, they can register for a HAC account online.

Students will be issued a username and password for their accounts by the school. Accounts for newly registered students will be created the day after the registration is completed in eSchoolPlus.

#### Clothing/Dress Code

It is hard to put those summer flip-flops away, but for safety, they ca not be worn to school. Please see the dress code below that you can consider while doing your child's school clothes shopping.

- Casual, loose clothing that allow children to move and play comfortably must be worn to school.
- Closed-Toe shoes must be worn. \*\*We recommend tennis shoes AND socks. NO clogs.
- Halter tops, spaghetti straps, skirts, dresses, or shorts that are not mid-thigh in length, see-through clothing, and off-the-shoulder blouses are NOT appropriate for school.
- Jewelry should not be worn to school.
- Pants that have holes/slashes cannot be worn.
- Hats and sunglasses cannot be worn in school unless medically necessary or when participating in a designated school spirit day.
- Clothing, hairstyles, or accessories that could be distracting to others are not to be worn to school.

### First Day of School

The first day of school is an exciting day for students, parents, and for the KES staff. To ensure that the day starts successful, we ask you to adhere to the following guidelines:

- Please consider letting your child ride the school bus if that will be there normal mode of transportation. Not only will that assist with the traffic flow that morning, it will also help to establish a routine for your child.
- If you do bring your child to school, please follow the adults directing the traffic in the parking lot. We ask that you say your good-byes BEFORE pulling up to the drop-off area, and have your child ready to exit the car.
- We are encouraging parents to drop their child off at the designated drop-off area, and allow them to walk in to the school alone. Again, this helps to establish a routine that they will follow the remainder of the school year. If you choose to walk them in, please know that this will only be allowed on the first day of school. Beginning August 11th, all students must walk down the hallway on their own

### **Medication Policy**

Florida Statute 1006.062 authorizes school personnel to assist students in the administration of prescription medications. Parents/Guardians are encouraged to administer medications at home prior to or after school hours. The schools do not keep stock medicine in the clinic. Nurse Tabitha is our full-time school nurse. Please contact her directly with concerns or questions. Her contact number is (904) 547-8552.

#### If your child needs medication during school hours, please note the following:

- All medications (prescription and over-the-counter) must have a medication form signed by both the parent/guardian and the physician ordering the medication.
- All medications must be received in the original container with current Rx label
  including student's name, dosage, and frequency of administration, physician's
  name, and expiration date of medication. Over-the-counter medications must be
  in the original, unopened container. No medication will be given if presented at
  school in a plastic bag.
- Medications must be brought to school by parent/guardian. Please do not send any
  medications with your child in their backpack. Medications may not be brought to
  school by the student.
- Medication brought to school by a student will be kept in the clinic until a parent/ guardian comes to the school with the required paper work. Without the required authorization, the student will not be given the medication during school hours.
- Medications should not be transported between home and school on a daily basis.
   Separate containers should be kept at home and at school.
- Expired medications will be disposed of upon expiration date in accordance with local requirements.









### Don't Be Left Out Access Form Needed

We would love for you to be involved in the memories being made each and every day at Ketterlinus. In order for you to enter the school passed the front office, an APPROVED School Access Form must be on file. The link to this form can be found on our school website or on the St. Johns County School District website. The approval process can take up to 4 weeks, so please submit as early as possible. This approval is needed for you to attend special events, enter your child's classroom, go to lunch with your child, attend parent/teacher conferences IN the classroom, or to chaperone field trips. Also, PLEASE have grandparents, aunts, uncles, siblings over the age of 18, and anyone else who might want to visit KES. We will not be able to allow anyone in to the school who does not have a cleared School Access form on file. Grandparents Day breakfast will be in September so please consider submitting forms now.
